Special Education was taken off formula in 1993-1994. Prior to that, most of the cost of special education was reimbursed to local school districts. Today, approximately 50% is reimbursed to school districts.

- School Districts must find every special education child within their population. Failure to do so can result in Compensatory Education Settlements.
- Instructional Support Teams (IST) and Response to Instruction and Intervention (RTII) must be used cautiously to avoid delaying the Child Find Process.

- Five Star Program (CSIU) \$178.14 \$218.03 per day
