#### Testimony for Economic Impact of COVID-19 on Pennsylvania Leisure-Hospitality Sector Senate Majority Policy Committee April 13, 2021 Matthew Knittel | Director | Independent Fiscal Office

Good morning Chairman Scavello and members of the committee. Thank you for the opportunity to submit material for this hearing. This submission includes two tables and two graphs which reveal the following trends:

- The first table shows the year-over-year job losses in the Commonwealth for two months: April 2020 (peak job loss) and February 2021 (latest data). The latest data for February show a year-over-year contraction of 441,000 jobs (-7.3 percent). (Excludes selfemployed.) In percentage terms, job losses are concentrated in the arts and entertainment (e.g., movie theatres, bowling alleys and gaming) and accommodation and food service sectors.
- The **second table** provides detail for those two sectors. For all subsectors, employment is down 30 to 40 percent from the prior year. The exception is limited-service restaurants (i.e., fast food) due to the continued use of drive-thrus.
- The **first graph** shows the percentage change in small business revenues for all small businesses and those in the leisure-hospitality sector relative to January 2020. The data show that small business revenue in that sector is down 55 percent, compared to 33 percent for all small businesses. (Note: These data are based on the location of the business, not the consumer. Small businesses are defined as firms with annual sales below Small Business Administration thresholds.)
- The **second graph** shows the percentage change in consumer spending based on credit and debit card purchases. Due to significant federal stimulus, total consumer spending was up 12 percent relative to January 2020, but spending at hotels and restaurants was down 9 percent.


